

# Welcome to Summer 2018 at Camp St. Charles!



## Check-In Procedures:

1. Check in with the Director. Laura Hall, or another member of the Leadership team, in the chapel. You will be directed to see the Camp Nurse if your child takes any medications, if there is something incomplete on your medical forms, or if you would like to speak with her. Bring all prescription and over the counter medications to be turned in. No medications are permitted in the cabins.
2. Go to your child's cabin and select a bed. Meet the counselors that will be working with your child in the cabin and discuss any concerns or special needs. Any counselor can assist you in locating your child's cabin. The girls' cabins are 1, 2 and 3, near the mess hall. The boys' cabins are Cabins 4,5 (located behind the mess hall building), and 6 (by pool). For Session I, Cabin 6 will be for girls.
3. You are all finished! Feel free to check out the grounds a bit before you leave. The camp store will have t-shirts, postcards and other camp goodies for sale in the mess hall. We ask all parents to leave by 3 pm so that we can get started. Take your cue from your child and the cabin staff and keep good byes short and sweet. Visiting day will be here soon.

1. To send mail to your child, be sure to allow plenty of time for the mail to reach him/her.

## 2018 Visiting Sunday Information

**12 pm-5 pm** June 24, July 8, July 22 and August 4

For the Campers safety: Please do not turn onto Stella Maris Drive prior to 11:45 am, the gate will be locked and morning activities will still be happening. In the past, parents have driven onto the fields during sports activities. As a courtesy to the residents of Stella Maris Drive, we ask that you wait on 257 (Rock Point Rd) if you arrive before 11:45am.

Mass will be celebrated at noon, all are welcome to join. **All children will assemble on the basketball court. Please meet your children there.** We celebrate Mass at the campfire area near the animals. Attendance at mass is encouraged by not required. Please do not visit the animals during mass.

After Mass: **1 pm-** Meet with your child's counselors! All counselors will be at their cabins from 1-1:30pm.

You may sign out your child for the day in the mess hall. Only parents and those who have a child custody form on file at camp will be permitted to sign out campers. (Please have photo id)

**1 pm – 5 pm** You are encouraged to bring a picnic lunch or purchase lunch from one of our vendors and enjoy the day with us at Camp. The swimming pool (water shoes are encouraged for all), boating, SUP and fishing from the dock, and giant swing will be open. We ask parents and other visitors to abide by the same rules that we have set for our campers. (Everyone must wear a lifejacket on the dock)

## 2018 Two Week Session Check Out Saturday Information

**10 am-11 am** June 30, July 14, July 28, and August 11

1. Sign out your camper at their cabin. Finish the brief survey.
2. Pick up medications and/or see the Camp Nurse in the picnic area behind Cabin 4. (in mess hall in the event of rain)
3. You may also stop in to see the Camp Director, Laura Hall, in the picnic area to receive your group photo and goody bag. If your child is interested in joining the Mentor program in 2018, be sure to ask for an info sheet.
4. Stop by the flag pole area to see if any of your child's things are in the lost and found area. After the last camper leaves, unclaimed items will be donated.
